# **GRAND KNIGHT MESSAGE**

SK Carroll Glass, Grand Knight, Council 4522

Brother Knights,

We lost a great Catholic last month with the passing of the Late Supreme Court Justice Antonin Scalia. He will be missed, Rest In Peace. One of the lessons that we all can learn from Justice Scalia is civility. "Civility is claiming and caring for one's identity, needs and beliefs without degrading someone else's in the process." — Tomas Spath and Cassandra Dahnke, Founders, Institute for Civility in Government. While he was a lion of conservatism and a champion of Originalism as Constitutional Interpretation, all was accomplished with good humor and without malice.

Whether he was writing for the majority or authoring a biting dissent, Justice Scalia's fidelity to his conservative "originalist" view of the law and his analytical mind have placed him alongside legal giants such as Louis Brandeis and Oliver Wendell Holmes Jr. Along the way, the intellectual force of his reasoning commanded appreciation. Justice Scalia was the lone dissent in Morrison v. Olsen: "That is what this suit is about. Power. The allocation of power among Congress, the President, and the courts in such fashion as to preserve the equilibrium the Constitution sought to establish. ... Frequently an issue of this sort will come before the Court clad, so to speak, in sheep's clothing: the potential of the asserted principle to effect important change in the equilibrium of power is not

immediately evident, and must be discerned by a careful and perceptive analysis. But this wolf comes as a wolf."

We are completing Lent and entering Eastertide. Pope Francis said, "Faith finds expression in concrete everyday actions meant to help our neighbors in body and spirit." Particularly during the Year of Mercy, he said, Catholics are called to recognize their own need for God's mercy, the greatness of God's love seen in the death and resurrection of Christ and the obligation to assist others by communicating God's love and mercy through words and deeds. "The root of all sin" is thinking that one is god, something often expressed in a total preoccupation for accumulating money and power, the pope wrote. And just as individuals can be tempted to think they have no need of God, social and political systems can run the same risk, ignoring both God and the real needs of human beings. Maybe, he said, "it was no longer fashionable" to preach about the daily actions of believers or maybe "our ecclesial practice has become quite institutionalized and politicized." I like to think that as Knights of Columbus, we are civil during this year of Mercy and onwards.
